INTERNATIONAL TOURISM REPORT: OVERVIEW OF ACCOMMODATION PERFORMANCE

1. Key markets and trends

1.1 Overview

International visitors to Australia spent a record \$38.8 billion in the year ending September 2016 – an increase of \$3.97 billion (11.4%) on the previous year. International visitor nights increased 3.8%.

In terms of reasons for travel, the holiday and education segments recorded growth of 25.3% and 16.7%, respectively.

The number of international visitor nights in unregulated accommodation has nearly doubled since 2007, growing from 61 million to 114.9 million. Over the same period international visitor nights in hotels, motels and serviced apartments has grown from 25.5 milion to 28.7 million. As such, unregulated accommodation accounts for four times the number of international visitor nights as regulated hotel, motel and serviced apartment accommodation.

In the year to September 2016, backpacker visitor nights declined 4.5% and backpacker expenditure declined 0.7%. Backpacker visitor nights fell most dramatically in Queensland, South Australia, Northern Territory and the ACT. Tasmania recorded significant growth in backpacker visitor nights and backpacker expenditure of 54.4% and 81%, respecitively.




