INTERNATIONAL TOURISM REPORT: OVERVIEW OF ACCOMMODATION PERFORMANCE

1. Key markets and trends

1.1 Overview

International visitors to Australia spent a record \$39.847 billion in the year ending March 2017 – an increase of \$1.9 billion (5.00%) on the previous year. International visitor nights increased 5.38%.

In terms of reasons for travel, the holiday and education segments recorded expenditure growth of 6.7% and 14.8%, respectively. Holiday visitor nights grew 6.1%, while education visitor nights grew 13.4%.

In capital cities (including Gold Coast), total visitor nights in the 'Hotels, Motels, and Resorts' category grew 10% to 22.5 million. The strongest growth was in Melbourne (18%) and Brisbane (12%). In regional locations, total visitor nights in the same category fell 0.32%, with the strongest growth in Tasmania (20%).

The number of international visitor nights in unregulated accommodation has grown 90% since 2008, growing from 64.5 million to 123.2 million. Over the same period international visitor nights in 'Hotels, Motels and Resorts' has grown 17.2% from 24.6 million to 28.8 million. As such, unregulated accommodation accounts for four times the number of international visitor nights as regulated hotel, resort, motel and serviced apartment accommodation.





5. Unregulated Accommodation

Tourism Research Australia has advised TAA that unregulated accommodation (i.e. Airbnb-type rentals) is presently recorded in two categories: 'Rented house/apartment/flat or unit' and 'Other Private Accommodation.' Accordingly, these two categories have been combined below and labelled 'Rented plus Other Private'.
