# 2021 EASTER WEEKEND & ANZAC DAY TRADING HOURS & CONDITIONS

Please find below information regarding Trading Hours and General Conditions, Extended Trading Permits and Menu Pricing for the Easter weekend and ANZAC Day Public Holidays.

# It is important to note that the hours specified only relate to the sale of Liquor.

97. Permitted hours generally

(1) Subject to this Act and to any condition imposed by the licensing authority a licensee <u>is authorised</u> to sell liquor during —

(a) such of the permitted hours specified in this Division; and

(b) such of the hours that may be specified under an extended trading permit.

This means that a venue could open outside of the permitted hours on the condition that liquor is not sold or consumed during those hours. For example, a hotel, tavern, or small bar could open for breakfast on Good Friday or ANZAC Day but MUST NOT allow the sale or consumption of liquor before midday

# PUBLIC HOLIDAYS

The public holidays for the upcoming Easter weekend and ANZAC Day as they relate to trading hours are:

- Friday 2 April 2020 (Good Friday).
- Monday 6 April 2020 (Easter Monday).
- Sunday 25 April (ANZAC Day)
- The public holiday on Monday 26<sup>th</sup> does not impact on trading hours

#### Small Bars, Restricted Taverns, and Restricted Hotels

Those venues with a current Emergency Occasional Licence may sell a six pack (of beer, cider or RTDs) and a bottle of wine <u>with a takeaway meal order</u> during permitted hours on the permit

# **RESTAURANT LICENCE**

# *ETP – Liquor without a meal*, the permit is only valid in line with hours permitted under Hotel Tavern and Small Bar Licences.

Those venues with a current Emergency Occasional Licence may sell a six pack (of beer, cider or RTDs) and a bottle of wine <u>with a takeaway meal order</u> during permitted hours on the permit.

#### MENU PRICING

Venues that charge a surcharge on certain days do not need to provide a separate menu or price list or have a separate price column with the surcharge factored in. However, the menu must include the words "a surcharge of [percentage] applies on [the specified day or days]" and these words must be displayed at least as prominently as the most prominent price on the menu.

If the menu does not have prices listed, these words must be displayed in a way that is conspicuous and visible to a reader. These measures apply to pricing for both food and beverages.
