	<p><b>Our primary service is the provision of food - OA3969</b>  The sale and supply of liquor to patrons is restricted to table service</p>	<p>30</p>	
	<p><b>An approved manager is on duty at all times at this venue -</b>  <b>Penalty \$10,000 - OA3970</b></p>	<p>30</p>	
	<p><b>Can you afford the risk? - OA3971</b>  Fines of up to \$10,000 for any person who supplies alcohol on licensed premises to anyone under 18 years of age</p>	<p>20</p>	
	<p><b>If you look under 25 we will ask you for ID – OA3972</b></p>	<p>20</p>
